

Adoption in Newfoundland & Labrador

In Newfoundland and Labrador, adoptions are facilitated by the *Department of Children*, *Seniors, and Social Development*. Currently, there are no private adoption agencies in Newfoundland. However, parents may choose to have family members adopt a child, or to have another individual foster the child until the parent or family is ready to care for a child.

What is Adoption?

Adoption is the legal process whereby a person or persons become a child's legal parent or parents.

How Do I Offer My Child for Adoption?

The Adoption Services Program finds permanent homes for children available for adoption. Social workers match children relinquished for adoption or who are in the continuous custody of the **Department of Children, Seniors, and Social Development** with adoptive parents. The program also approves applications to adopt a child from other Canadian provinces and territories, and foreign countries.

What Types of Adoptions Are Available?

Domestic-Infant (age 0-24 months):

Applicants may apply to adopt a child under the age of 24 months who is eligible for adoption in Newfoundland and Labrador. The provincial waiting period is approximately eight years

depending on the number of infants available for adoption.

Domestic-Older Child (over 24 months):

Applicants may apply to adopt a child over the age of 24 months who is eligible for adoption in Newfoundland and Labrador. The provincial waiting period depends on the number of older children available for adoption. Older children available for adoption are usually in the continuous custody of a Manager of Children, Seniors and Social Development.

Interprovincial Adoptions:

Applicants may apply to adopt a child who is identified as available for adoption by another province or territory of Canada. The *Department of Child, Youth and Family Services* will work with adoption authorities in the child's province of birth to facilitate the adoption. Applicants must meet the requirements for adoption under the Adoption Act in Newfoundland and Labrador, and any requirements of the province/territory where the child is born.

Intercountry:

Applicants may apply to adopt a child from a foreign country. Applicants must meet the requirements for adoption under the *Adoption Act*, 2013 for Newfoundland and Labrador. They must also meet the requirement of the country from which they choose to adopt a child. Applicants typically use a private adoption agency licensed in Canada and the foreign country to help facilitate this complex process. Currently, there are no private agencies in Newfoundland and Labrador. Applicants usually avail of services of agencies located in other provinces.

Step-Parent/Relative:

Step-parents and relatives (parent, grandparent, aunt, uncle, or sibling of a child by birth or adoption) may apply to adopt a child using the Step-Parent/Relative or Person with Permanent Custody of a Child Self Help Kit.

Services to Birth Parents:

The Adoption Act requires that birth parents be given information regarding adoption, the types of adoption and alternatives to adoption. Providing information about the alternatives to adoption is essential in order for the birth parents to make a fully informed decision about the permanent plan for a child. Birth parents can contact a social worker at their local CYFS office to determine if they wish to make an adoption plan for the child.

Access to Adoption Information/Post Adoption Services:

The Adoption Act (2003) provides for greater openness in the release of adoption information. Persons adopted under this Act may, at age 19 years old, apply to Vital Statistics for copies of their original birth registration, adoption order, and amended birth certificate.

When an adopted person has reached their 19th birthday, both the adopted person and birth parents may receive from Vital Statistics copies of:

- the adopted person's original birth registration
- the amended birth registration with the name following adoption
- the adoption order with the adoptive parent information removed to respect their right to privacy.

For adoptions finalized prior to April 30, 2003, adopted persons, at age 18 years, and birth parents who wish to maintain their confidentiality are provided with the opportunity to file a disclosure veto or no-contact declaration. The disclosure veto or no-contact declaration remains in effect until cancelled in writing or until one year after the death of the person who filed it.

An adopted person under the former Act and adult relative may register with the Provincial Director to exchange identifying information providing no disclosure veto or no-contact declaration has been filed.
